**General and Regional Elections  
(Addresses of Returning Officers and Supernumerary Returning Officers)**

Whereas Section 8 (3) of the Representation of the People Act, Chapter 1:03, provides that forthwith upon taking the Oath prescribed by subsection (1), the Returning Officer shall establish an office for his District and cause an advertisement to be inserted in a newspaper circulating in the district specifying the place where he has established his office:

And whereas each of the Returning Officers named in the first column of the first schedule has taken his Oath as aforesaid and has established an office in his District as mentioned opposite his name in the second column.

Now therefore at the request of the said Returning Officers, I do hereby give notice that the place at which each of the said officers has established his office is the place specified opposite to his name in the third column of the schedule.

And whereas Section 7(1)(ba) of the Representation of the People Act, Chapter 1:03, provides that there shall be a Supernumerary Returning Officer for each Sub-District in the case of Districts 3, 4 and 6 being sub-divided into three (3), four (4) and three (3) sub-districts respectively, I do hereby give notice that the place at which each of the said officers has established his office is the place specified opposite to his name in the third column of the second schedule.

## AMENDED NOTICE

### **General and Regional Elections** **(Addresses of Returning Officers and Supernumerary Returning Officers)**

On 18th June 2025, the Chief Election Officer published a Notice in the Gazette, on behalf of the Returning Officers, to give notice of the Offices of the Returning Officers and Supernumerary Returning Officers. That Notice was titled “**General and Regional Elections (Addresses of Returning Officers and Supernumerary Returning Officers)**”.

In that Notice, the person the identified in the First Schedule as Returning Officer for the Registration (Polling) District for Region No. 7 was named incorrectly as “Dwayne Williams”.

This Notice is to provide such clarity that the name of the Returning Officer for the Registration (Polling) District for Region No. 7 is **Wayne Williams**.

In that Notice, also, the person the identified in the Second Schedule as Supernumerary Returning Officer for the Sub-District 2 -St Lawrence to Cornelia Ida Sub-District of the Registration (Polling) District for Region No. 3 was named incorrectly as “Timona Kasim”.

This Notice is to provide such clarity that the name of the Returning Supernumerary Returning Officer for the Sub-District 2 -St Lawrence to Cornelia Ida Sub-District of the Registration (Polling) District for Region No. 3 is **Timona Kazim**.

In that Notice, also, the address of the Office of the Supernumerary Officer for Sub-District 2 -St Lawrence to Cornelia Ida Sub-District of the Registration (Polling) District for Region No. 3 was recorded incorrectly as “Public Road, Nouvelle Flanders Registration Office, WD 23 Public Road Pouderoyen, West Bank Demerara”.

This notice is to provide clarity that the address of the Supernumerary Returning Officer for Sub-District 2 -St Lawrence to Cornelia Ida Sub-District of the Registration (Polling) District for Region No. 3 is **Public Road, Nouvelle Flanders Registration Office, Nouvelle Flanders, West Coast Demerara**.
