**THE NATIONAL REGISTRATION ACT**

**(CAP. 19:08)**

**IN EXERCISE OF THE POWERS CONFERRED ON THE ELECTIONS COMMISSION BY SECTIONS 6(1)(a), 6A, 14, 14A, 15 AND 16 OF THE NATIONAL REGISTRATION ACT, AND REGULATIONS 14, 14A, 14B AND 22 OF THE NATIONAL REGISTRATION (RESIDENTS) REGULATIONS, THE ELECTIONS COMMISSION MAKES THE FOLLOWING ORDER:**


Citation	1. This Order may be cited as the National Registration (Claims and Objections) Order 2025.
Qualifying date	2. The qualifying date with reference to which this Order applies shall be 30 <sup>th</sup> June 2025.
Application of this Order	3. This Order shall apply to all persons who are qualified, with reference to the qualifying date, for registration as an elector in accordance with the Laws of Guyana, including those who desire to make corrections or effect changes to their name, address or other particulars.
Purpose of this Order	4. This Order, and the Claims and Objections period for which notice is given herein, is intended to facilitate the production of revised lists of electors for the registration divisions in each of the Registration Areas set out in the First Schedule to this Order.
Conduct of claims and objections	5. Claims and Objections may be submitted and enquiries may be carried out concurrently during the period identified in the Second Schedule, provided that the submissions are made within the prescribed times set out therein.
Notice of prescribed times for claims and objections	6. The days set out in the second column of the Second Schedule shall be the days during which the matters set out in the corresponding entry in the first column of that Schedule shall be done.

2. The days on which claims in respect of entries in the Preliminary List shall be tendered to the Registration officer of each Registration Area so as to be received by him/her.	16 <sup>th</sup> June 2025 – 18 <sup>th</sup> June 2025 (inclusive)
3. The days on which objections may be tendered to the Registration Officer of the Registration Area against the inclusion of names on the Preliminary List.	16 <sup>th</sup> June 2025 – 20 <sup>th</sup> June 2025 (inclusive)
4. The day not later than that which the Registration Officer shall begin to hear and determine objections and appeals.	18 <sup>th</sup> June 2025
5. The days on which applications may be made by persons whose names appear in the Preliminary List for change and correction of particulars as shown in the List and effect transfers from one Registration District/Division/Sub-Division to another	16 <sup>th</sup> June 2025 – 18 <sup>th</sup> June 2025 (inclusive)
6. The day not later than which all forms of objections and applications for corrections of particulars shall be sent by the Registration officer to the Commissioner of Registration	22 <sup>nd</sup> June, 2025
7. The day not later than which the Commissioner of Registration makes alterations to the Preliminary List to give effect to the decisions on claims and objections.	3 <sup>rd</sup> July, 2025
